

NATIONAL MANGO BOARD MANGO SELFIE SWEEPSTAKES □ OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. All federal, state and local laws and regulations apply. Void where restricted or prohibited by law.

1. ELIGIBILITY: The National Mango Board Mango Selfie Sweepstakes (“Sweepstakes”) is open to individuals 18 years of age or older as of date of entry and who are legal residents of any of the 50 United States or the District of Columbia. Employees of National Mango Board (“Sponsor”) and participating retailers (“Retailers”), and each of their respective contractors, affiliates, subsidiaries, dealers, distributors, suppliers, and their immediate family members and those living in the same household are not eligible to win.

2. HOW TO ENTER: Sweepstakes begins at 12:00 AM (ET) on January 14, 2018 and ends at 11:59 PM (ET) on February 24, 2018 (“Promotion Period”). The Promotion Period consists of six (6) separate weekly sweepstakes entry periods each beginning at 12:00 AM ET on Sunday, starting January 14, 2018, and ending the following Saturday at 11:59 PM ET (“Weekly Entry Period”). To enter, post a photo of yourself with a mango (“Mango Selfie”) on your public Instagram profile. In the caption of your Mango Selfie, include “#mangoselfie” and “@mangoboard”. Also follow the National Mango Board (@mangoboard) on Instagram. Both tags must be included and you must follow @mangoboard for your entry to be valid. After the close of each Weekly Entry Period, the National Mango Board will collect all of the tagged photos that meet the specifications listed above and these will be the (“Valid Entries”) for that Weekly Entry Period. Make sure your Instagram profile is set to be public or your posted photo will not be entered.

Entrants agree to be bound by and acknowledge compliance with these Official Rules including eligibility requirements. Limit one entry per person per Weekly Entry Period. In the event of a dispute as to the identity of the entrant, the entry will be considered made by the authorized account owner of the Instagram account at the time the entry was submitted. “Authorized account owner” of an Instagram

account is the natural person in whose name the Instagram account has been issued. A selected winner may be asked to provide Sponsor with proof that the selected winner is the authorized account holder of the Instagram account associated with the winning entry. If a dispute cannot be resolved, the entry will be deemed ineligible. Use of automated devices not valid for entry. Entries become the exclusive property of the Sponsor and will not be returned. 3. PRIZES: Sixty (60) Prizes will be awarded, ten (10) per week during the six (6) week promotional period: \$25 American Express® Gift Card (terms and conditions apply). Total Retail Value of all Prizes: \$1,500.00. No substitutions for prizes except by Sponsor or as may be necessary due to unavailability, in which case prize of equal or greater value will be awarded. Prize is not transferable or redeemable for cash. All taxes and other expenses not specified herein are the sole responsibility of the winner. Sponsor responsible only for prize delivery; not responsible for prize utility, quality or otherwise.

4. RANDOM DRAWING: Ten (10) winners per Weekly Entry Period will be selected in a random drawing approximately two days following the conclusion of each Weekly Entry Period from all eligible entries received. Each winner will be notified via the Instagram account through which the winner entered the Sweepstakes. Winners will have three (3) days to respond via the e-mail address provided with their name, mailing address, email address, telephone number and birth date to confirm that they are 18 years of age or older. Failure to respond within the designated timeframe will result in the selection of an alternate winner. The drawing will be conducted by an independent judging organization, whose decisions are final on all matters relating to the

Sweepstakes. Limit of one winner per household for the duration of the Promotion Period. Any prize returned as undeliverable will be awarded to an alternate winner.
